Property Tax Notices

The Municipality of South Huron has been working on updating its financial software to provide a more cost efficient service to our customers. To accommodate these changes, the public is advised that the first 2019 Interim Tax Installment due date has been extended to April 1st, 2019. The second Interim Tax Installment due date will remain set for June 15th.

The Interim Tax Notices will have a whole new look as a result of the new municipal software. The same information will be included as always on the interim notice, that information will just appear in a different format.

Commercial/Industrial Property Owners – Vacancy Rebate Applications

A reminder that applications must be received no later than February 28, 2019 for the 2018 tax year where buildings were entirely or partially vacant for a period of 90 (consecutive) days and mandatory criteria are met. Applications are available at the South Huron Municipal Office or on our website www.southhuron.ca.

Reminder – Municipal Road Allowance! To ensure proper drainage and for motorist's safety & visibility, the municipal road allowance is not to be planted with crops. Any road allowances that are currently tilled should be restored to a grassed area as crops planted on municipal property may be removed. The average road allowance is 66 feet.

Property Owners – Mailing Address Changes and Updates:

To ensure you receive all your municipal billings and documents in a timely manner, you must advise the Municipality of any and all changes to your mailing address, owner name changes and details, payment change details (ie. bank/mortgage company paying or not paying taxes, etc.). Failure to do so may result in penalties being added to your account and/or not receiving important notifications.



Assessment Changes – All assessment changes for the current year received from the Municipal Property Assessment Corporation (MPAC) after the return of the annual assessment roll, will be processed after the final tax levy for the 2019 taxation year has been completed. Supplemental tax notices are mailed out for these changes, once processed later in the year.
