## Finding the right site for your business

There are several ways to search for a suitable location within South Huron, depending on your business's needs and preferences. Some companies opt to hire a professional site selector or a commercial realtor who specializes in finding the right property. Others prefer to rely on their in-house team to conduct the search independently.

It's also beneficial to explore local resources and networks when searching for a location. Engaging with the local business community can provide valuable insights and recommendations on potential locations that may meet your needs.



# BEFORE finalizing a lease or purchasing any property:

It is crucial to **consult with the Municipality's Building and Planning staff**. They can confirm whether the intended use of the property aligns with the Ontario Building Code, Ontario Fire Code and local zoning regulations. This step is vital to ensure that the property is zoned appropriately and the building complies for the applicable codes for your business activities.

#### For more information on building and zoning requirements, be sure to:

- Check the property's zoning and permitted uses, structures, zone provisions by viewing the **Municipality of South Huron Zoning By-law** (see Speaking with a Planner section in this guide for more information).
- Review the **Ontario Building Code (2024)** to understand what a building permit is and when one is required (see Building Permit section in this guide for more information).
- Review the **Ontario Fire Code (O. Reg 213/07)** to understand what may be required for your property (see Fire Inspection section in this guide for more information)

Taking these precautions will help avoid any future complications or delays in your business's operations.



## Speaking with a Planner

Speaking with a Planner will assist you with answering any questions you may have regarding zoning designations of a building/property in relation to your business.



#### You should contact a Planner in our Planning and Development department if:

- You are unsure if your property is zoned correctly (Municipality of South Huron Zoning By-law) for your proposed business;
- You require an official plan or zoning by-law amendment, or site plan approval;
- You have a question about heritage buildings or designations; and
- You require a minor variance at the Committee of Adjustment.

## Building Permits – What is it and when do you need one?

A building permit is your formal permission from the Municipality of South Huron to begin a building project, such as the construction, demolition, renovation or addition of any building. South Huron Building staff must review your plans to ensure that they comply with the **Ontario Building Code (2024)**, **Municipality of South Huron Zoning By-law** and other applicable regulations.

The Ontario Building Code (2024) requires that you obtain a building permit before you start work on a new structure or an addition or alterations to an existing structure.

Examples of when a permit **is required** may include:

- Constructing or renovating a building
- Structural alterations of the interior of a building;
- Changing the use of the building (for example from office to retail space);
- Remodeling plumbing and heating systems;
- Installation or alteration of a commercial cooking equipment.

Examples of when a permit **is not usually required** may include;

- Painting and decorating;
- Landscaping;
- Eavestrough (installation or replacement);
- Minor repairs to bricks or blocks, etc.



## How to apply for a Building Permit

South Huron uses **Cloudpermit** (online permit application system) for submission of a Building Permit. We do understand that not everyone is able to submit digital files and we still accept hard copy submissions to our office.

## Building Permit – Other Requirements

If applicable, the following may also be required through the Municipality:

- Plumbing Application and fee required for any work that involves altering or installing new plumbing systems, including additional fixtures, drainage, venting, or private water, sanitary, or storm sewer systems
- Application for Water/Sewer Service required for all applicants requesting a new or updated water or sewer connection.
- Application for Entrance required for all applicants requesting new or modified entrances.
- Energy Design Summary (EEDS) a detailed energy efficiency design summary for buildings under specific regulations
- Schedule 1 to be completed in accordance with building code requirements
- Commitment to General Review by Architects and Engineers – this form ensures that qualified professionals will be overseeing the project's compliance with relevant standards and regulations.

#### External Approvals/Permits

Depending on your project, you may require the following external approvals/permits:

- Electrical Safety Association – Certificate of Acceptance
- Conservation Authority permit
- Huron Perth Public Health approvals (for example potable water, food premises)

## Occupancy Permit – What is it and when do you need one?

#### Occupancy permit ensures that the building meets all necessary construction and safety standards.

An occupancy permit is one of the last inspections to complete a building permit. An inspection must be conducted prior to use or occupancy of the space. This ensures that any construction done to the space meets the building code and provides first responders with relevant information in case of an emergency.

Once all requirements in the Ontario Building Code have been completed, an inspection through **Cloudpermit** is requested and will be conducted by the Building Department. Once all requirements are met, the Occupancy Permit will be issued.

## I want to install a sign for my business – Do I need a permit?

The **Municipal Sign By-law** and/or the Ontario Building Code regulates the size, location and number of signs that are permitted on any property, business and/or at special events within the Municipality of South Huron.

All businesses looking to put signage on their premises, whether for an existing building or a new design-build space, ground signage or mobile signs will be required to obtain a sign permit and will require permission from the owner of the property.

Certain signs in the Municipality of South Huon may require both a **sign permit** and a **building permit**. To apply, you must submit both permit applications, often including detailed plans or drawing.



## How to apply for a Sign Permit:

## **Liquor Licence**

A liquor licence authorizes businesses and organizations to legally sell and serve alcoholic beverages to the public. These licences are issued by the Alcohol and Gaming Commission of Ontario (AGCO), the provincial body responsible for regulating alcohol sales and service.



Individuals applying for a new Liquor Licence in South Huron can submit their initial application online through the AGCO website. However, applicants are still required to submit a completed municipal form, signed by the Municipal Clerk, along with the a number of supporting documents – the municipal form and support documentation list can be found on our **Liquor Licence** Page.

Once all letters are received, staff will circulate the request to Building Services and the Fire Department for review. The Clerk will then review the completed documents and send the applicant an email with the approved documents, which the applicant is responsible for submitting to the AGCO.

# Temporary Extension to Liquor License (Seasonal Patio Program)

For those applying for a temporary extension to their liquor licence, recent amendments to the Liquor Licence and Control Act, 2019, have shifted the approval authority for temporary outdoor extensions (temporary patios) from the AGCO to local municipalities. Applicants for a temporary extension must submit their application and necessary documents to the Municipality for review.

## **Seasonal Patio Program**

This program is available for businesses looking to establish an outdoor patio on Municipal property or for licensed businesses seeking a temporary extension of their liquor licence.

To apply, businesses must complete the application form and submit a legible sketch, site plan, or aerial photo of the proposed outdoor patio. Once approved, businesses are required to display their permit when the patio is open to the public. Additionally, restaurant owners must notify the **Alcohol and Gaming Commission of Ontario** (AGCO) before selling and serving liquor on their seasonal patio.

Businesses must reapply to the program each year for approval. The program is not applicable to outdoor patios on private property. The Municipality of South Huron launched the seasonal patio extension program in 2023 to support local businesses looking to establish an outdoor patio on Municipal property or for licensed businesses seeking a temporary extension of their liquor license.

## **Fire Inspection**


The Fire Department performs inspections based on request, complaint, safety concerns and routine basis. Utilizing authorities, powers, duties, and responsibilities set out under provincial legislation, the Fire Protection and Prevention Act, 1997 (FPPA), Fire Inspectors enforce the Ontario Fire Code.

During an inspection, the Fire Department will look for compliance with the Ontario Fire Code. Here is a short list of potential items an inspector will look for:

- Blocked / obstructed exits;
- Fire extinguishers;
- Fire separations and their integrity;
- Smoke alarms and carbon monoxide alarms, where required;
- Records of tests for fire safety equipment;
- Improper storage of flammable liquids or gasses;
- Unsafe accumulations of combustible materials;
- Fire safety plans.

Fire inspections are also completed to meet licensing requirements for:

- Liquor licensing;
- Transient Trader license (refreshment and food vehicles).


